The information you provide is used to fulfill your specific request. This information is only used to fulfill your specific request, unless you give us permission to use it in another manner (ex., to add you to one of our mailing lists).

We may use third-party advertising companies to collect data and/or serve ads when you visit our Website. These companies may use information (not including your name, address, email address or telephone number) about your visits to this and other Websites in order to provide advertisements about goods and services of interest to you. Cookie/Tracking Technology

The Website may use cookie and tracking technology depending on the features offered. How Information Collected Is & Can Be Used

- Evaluating analytics to see how our customers engage with the Website

In addition, we may need to keep your billing information on file for an extended period of time to maintain our internal transaction records.

We do our best to keep your private information secure and safe. Most of your personal information is encrypted and therefore protected from being accessed by outside users. However, data leaks and malicious attacks do happen. Please understand that while we do our best to protect your data, providing your personal information is at your own risk.
